session 1986-87 for a day school (single shift)

Sir,

With ref. to your application on the subject  
cited above, I am directed to grant recognition to your  
school from class Ist to VIIIth (without aid) w.e.f. 1986-87  
session subject to the fulfilment of the following terms  
and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules, 1973 framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Trans-Yojna area.
3. That the school shall appoint full time qualified and eligible staff for all the classes of the school as per the norms of the Deptt.
4. That the school shall equip the Science Lab. as per the norms of the Department and suitable facilities for practical work shall be provided to the students and more material worth Rs.2000/- may be purchased.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as to the teachers. Books as per the ratio of 10 books per student may be added and facilities of reading-room may also be provided immediately & Rs.3500/- may be spent immediately on approved books.
6. That adequate sports materials shall be purchased and made available to the students immediately & more sports material worth Rs.2500/- may be purchased.
7. That the school shall strictly abide by the provisions of Sec.10(i) of the Delhi School Education Act & Rules, 1973.

8. That the teachers shall not exceed the number as per the school class-room and as per the Education, Delhi in a class. Number of seats should not exceed the number of passage size in the school.
9. That the school shall be primary and unrecognised classes activities within the school premises recognised classes shall be recognised classes be removed from the premises. No branch of this school shall be in the banner of the recognised school.
10. That the school shall provide all the services of unqualified staff for any, immediately.
11. That the school management and the employees shall be immediately.
12. That all the provisions under Rule 50 & 51 of the Delhi School Education Act, 1948 shall be strictly observed.
13. That the management shall provide drinking water shall be provided to the students as well as to the teachers. All also be provided with the health Certificate obtained from within a month.
14. That the management shall create a fund of Rs 5000/- (Rupees only) in a bank in the name of Education Manager in any scheduled bank within a month.
15. That the management shall issue orders/conditions/and the Department shall lead the management of the school. That the school shall be in the school with the permission of Education Delhi.
16. That the management shall procure land from the Government building shall be constructed as per the Department.
17. That the management of the above.

conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six month.
